

## WASTE MANAGEMENT RULES IN THE VEITSILUOTO HARBOUR

## **GENERAL RULES / MANDATORY DELIVERY OF WASTE**

Waste collection station in the Veitsiluoto harbour is spotted on the map, please see reverse side of this guide. Upon arrival to the Port of Kemi, the master shall give notification of the waste generated by the ship and of cargo residues. The notification shall be given to Boatman no later than 24 hours before arrival or, if the duration of the voyage is less than 24 hours, immediately upon departure from the previous port. If the port of call is known less than 24 hours before arrival, the notification shall be given as soon as the port of call is known. Mandatory notification does not apply to liner vessels subject to exemption decision by Finnish Transport Safety Agendy (TraFi). The waste information must be done following the guidelines of TraFi: https://www.trafi.fi/en/maritime/marine\_pollution\_prevention/delivery\_of\_ship-generated\_waste

Neglect in following the waste separation rules lead to invoicing the ship for incurred extra costs such as separation, safety, transportation, disposal costs.

SHIP-GENERATED LIQUIDS AND SOLID DANGEROUS WASTE
It's strictly forbidden to leave dangerous waste anywhere else than to Boatman!

Dangerous waste is received only according to pre-notification. The notification shall be given to Boatman +358 40 548 2065 or shipping agent +358 207 428 219 no later than 24 hours before arrival. After giving the dangerous waste to Boatman, he will deliver it to the dedicated container. Dangerous waste fee will be charged, it is not included in the prevailing no-special-fee system. It is strictly forbidden to leave dangerous waste anywhere else than to Boatman!

Oily waste Pilge water, waste oil, ballast water of tankers, tank wash water	•	<b>66.</b>	Pre-notification to ship agent (+358 400 695 280) 24 hours prior to delivery. Ship oil and bilge water must not contain any other chemicals. Compulsory pre-notification in case there is other chemicals mixed to oily waste.
Pyrotechnic devices Emergency rockets, smokes etc.		A CONTRACTOR OF THE PROPERTY O	Pre-notification to Boatman (+358 40 548 2065), who will carry pyrotechnic waste to the final destination.
Dangerous waste			Chemicals must be kept separately and in its own package, which must contain clear and readable markings about the content. Examples of dangerous waste are grease, vaseline, paint, solvents, fluorescent lamp batteries, oily waste, oily wipes, oil filters. See general guides above. Pre-notification to Boatman (+358 40 548 2065), who will supervise the delivery to the final destination.
Energy waste / burnable waste			Energy waste covers safely burnable waste eg. plastic bottles, bags boxes, wood, paper, carton without any glue. Must be separated to the bin dedicated to energy waste.
Glass		~ 060	Must be separated to the bin dedicated to glass, no porcelain.
Metals		66660	Must be separated to the bin dedicated to recycle metals
